Bruton: 25/02698/HOU **Glendale Higher Tolbury BA10 0DJ** Timber deck and changes to windows and doors.

Fivehead: 25/02678/S73A **Land Os 0082 Part Lower Swell, S73A** Application to vary Condition 2 (approved plans) to allow the addition of 4no. rooflights, 2no. each to the South facing roof slope and the West facing roof slope in relation to planning approval 21/03729/FUL; Application for the demolition of the existing barn and the erection of a single dwelling.

Kingstone: 21/02654/FUL **Land OS 6300 Longforward Lane, TA17 8TB** Erection of buildings to store and facilitate the construction of carnival floats.
