Ansford: 25/03089/FUL Land OS 4910 And OS 6011 North of Burfitt Road And South Of Ansford Hill Erection of 49 dwellings including affordable housing, access proposed from Burfitt Road, provision of pedestrian access and crossing over Ansford Hill, public open space and ancillary works.

Bruton: 25/03074/FUL & 25/03075/LBC Ames House, Wyke Champflower, BA10 0PR Conversion of a barn within the curtilage of a Grade II listed building to provide short-term holiday let accommodation (part implemented).
